## IMPORTANT INFORMATION! PLEASE READ AND SIGN BELOW

**REFUNDS:** Refunds are only available on a camp credit basis that can be redeemed at a later time and are only offered to campers that undergo a severe illness or if a natural disaster occurs (Hurricane, Tropical Storms, etc.). Refunds will be made only to the original payee and may not be used by someone else.

**ABSENCES:** Refunds are not available for vacations, special events, short-term illnesses of four (4) days or less, or other personal commitments that prevent attendance. However, a refund may be available for an extended illness if the student is absent the entire week. A note from the hospital/doctor and written note from the parent or guardian explaining the situation must be received in order to approve a camp credit refund.

**DISMISSAL FROM CAMP:** There are times when the camp must dismiss a child due to a psychological, emotional, or physical disability that precludes the child from participating safely or effectively in a group. Dismissal will take effect only after consultation among the parents, camper (if appropriate), and the Camp Director. Dismissal for the aforementioned reasons will result in a complete refund for the unused days. On occasion, dismissal may be necessary for disciplinary reasons. This action will take effect only after consultation among the parents, camper (if appropriate), and the Camp Director. If a camper is dismissed for disciplinary reasons, there will be **NO REFUND** for the unused days.

**MANDATED REPORTING:** Summer Fun Kids Camp employees are mandated, by Florida State Law, to report any suspected cases of child abuse or neglect directly to the appropriate authorities for investigation. While we have established internal procedures to facilitate reporting and apprising supervisors, we cannot, by law, require our employees to disclose his or her identity to anyone.

**PAYMENTS:** All weekly payments (weekly tuition, lunch fees, and before/aftercare fees) are due by Monday morning of each week. **NO EXCEPTIONS!**

**CAMP T-SHIRTS:** For your child's safety, **all campers are required to wear their camp T-shirt everyday.** Any camper that does not bring a camp T-shirt will be provided with one and the parent/guardian will be charged \$12.00.

**PHOTO CONSENT:** Any photographs taken of the campers by Camp Staff or their representatives are used for editorial and/or promotional uses only. If you feel you don't want your child's photo to be taken, please submit your concern in writing to the Summer Camp Office.

1. \_\_\_\_\_ **CAMP T-SHIRTS**

Campers must wear their camp T-shirt everyday. Campers who come to camp without their camp T-shirt will be given a shirt and the parent will be charged \$12.00. Please have your child's T-shirt tag marked with your child's camper number.

2. \_\_\_\_\_ **LATE PICK-UP \*\*\* (PLEASE READ CAREFULLY) \*\*\***

Parents that pick-up their child(ren) after 6 p.m. will be charged **\$1.00 PER MINUTE AFTER 6:00 P.M.**  
**NO EXCEPTIONS! Must be paid in full at time of pick up (cash or check)**

3. \_\_\_\_\_ **PERSONAL LUNCHES**

Students that do not take part in the camp lunch program must bring a lunch that does not need to be heated. Microwaves are not available. ***Campers must bring disposable lunches in a zip lock bag on field trip days.***

4. \_\_\_\_\_ **FIELD TRIPS\*\***

All campers **must** attend the field trips. If campers do not want to attend a field trip they **may not attend camp** on that specific day.

\*\*Field trips for Pre-K4 at Gladeview campus are an optional activity with no additional charge.

Students in Pre-K4 may stay on campus if the parent chooses for their child not to attend.

**\*\*K4 students that do not attend the field trips must have a signed Regrets Only Form for each trip.** All campers must arrive on time on field trip days. *Campers who arrive late for a Friday field trip will be left behind and will need to go back home with the parent.*

Poor weather conditions can force outdoor field trips to change and be re-routed to an indoor activity. Parents are encouraged to contact the Camp Office and receive updates on the field trip status.

5. \_\_\_\_\_ **SWIMMING POOL POLICY**

We usually schedule several aquatic park field trips for the summer. Campers in groups 3, 4, 5, & M that are good swimmers may participate in both the swimming pool and water playground areas of the aquatic park. Those campers who are not good swimmers may not participate in any swimming pool activities. Campers that are not given permission by the parent will remain in the water playground area only. No Swimming.

6. \_\_\_\_\_ **BEFORE/AFTER CARE**

Before/After Care services are **NOT** included in the weekly rate. It is provided for an additional weekly fee.
